DON'T WRECK YOUR CASE FROM THE START ASK ME, NOT DAVE OR GARY!

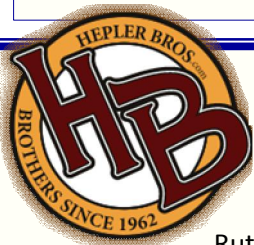
